### **THIS IS A SPECIAL ABBREVIATED HURRICANE EDITION:**

Special thanks to Senator Rick Scott and FEMA Administrator Deanne Criswell for coming to our City this week to assess hurricane damages. We are grateful for your concern, support and encouragement that you will be there to help us get through the cleanup and restoration process.

# **Hurricane Milton Updates:**

- \* A curfew is in place from 12 a.m. until 6 a.m. to keep streets secure during initial period after the hurricane while power is out. https://www.ci.punta-gorda.fl.us/home/showpublisheddocument/15920
- \* How high did the water get? The working estimate in the City limits is about a foot higher than Helene. Where we have a sensor at the Shell Creek dam indicated (measured at above zero ground elevation) 7.1 feet for Helene and 9.12 for Milton with reverse flow pushing in. It will take time before an official depth is available.
- \* For power restoration information visit <u>FPL.com</u>. As of Sunday, October 13 at 4 p.m., there are still 9,660 customers without power out of 133,360 customers. They restored 123,700 customers already! They estimate they will have 95% power restored by Tuesday, October

15 at the end of the day. Thanks to the heroes from FPL and their partners from all over the country who put their lives on hold to come and restore power to all of SW Florida! Not all heroes wear capes!

- \* Trash pickup and recycling pick up are back on their regular schedule. Yard waste will not be picked up at this time.
- \* City Clerk's office and Finance Department have been relocated to the third floor of the City Hall Annex due to flooding in their offices at the Herald Court location.
- \* Building Department will be back at work Monday morning at 8 a.m. and have an expedited online permitting process in place on the website to help residents get permits in a timely manner.
- \* There are no boil water notices in effect. We do ask that people limit water use wherever possible.
- \* Following a hurricane, stagnant water can pose significant health risks by harboring harmful pathogens, which may lead to serious waterborne disease. This standing water can also conceal dangerous hazards, including storm debris and downed power lines, creating a serious risk of electrocution for those who venture too close. It's crucial to exercise caution and prioritize your safety. Always remember: "Turn Around, Don't Drown!" Stay vigilant and avoid flooded areas to protect yourself and your loved ones from potential dangers.
- \* City offices will be reopening on October 14. Due to flooding and standing water Hounds on Henry remains closed until further notice.
- \* Gilchrist Park restrooms are currently closed due to flooding. We are working on a solution to reopen the restrooms soon.
- \* Ponce De Leon Park is currently closed to all visitors due to hurricane damage until further notice.
- \* City Council will meet at 9 a.m. on October 16, location will be announced as soon as a suitable location with power is determined.
- \* Senator Rick Scott visited Punta Gorda Thursday to meet with members of the police and fire departments as part of his effort to assess the damage caused by Hurricane Milton. During his visit, he had the opportunity to see the Fat Truck in action a high-water rescue vehicle generously provided by Supertrak, which played a critical role in the City's emergency response efforts.
- \* The Administrator of FEMA Deanne Criswell and her team met with Punta Gorda staff to view hurricane damage, discuss needs, grant opportunities and assistance with FEMA programs.

# **Hurricane Recovery Information:**

- \* Residents affected by Hurricane Helene may be eligible for FEMA assistance. Fill out an application at https://www.fema.gov/assistance/individual.
- \* Clean up help is available through Crisis Cleanup (844) 965-1386.

- \* If you need help connecting with your loved ones after Hurricane Milton, the American Red Cross can assist you. The Reunification Plan tools can help if assistance is needed locating a missing friend or relative because of a current disaster. Call 1-800-RED CROSS (1-800-733-2767) and provide as much detail as you can to assist us in potentially locating your missing loved one.
- \* Currently, nearly all decorative streetlights in the downtown area and historic district, as well as lighting in Gilchrist Park and Laishley Park, are inoperable. Additionally, pathway lighting along the Harbor Walk and Linear Trail is also out of service. Officers will be heavily patrolling these areas during nighttime hours to enhance safety.

Charlotte County has opened three distribution centers today with water, tarps and MREs. The points of distribution are open 8 a.m. to 6 p.m. or while supplies last at the following locations:

- \* Port Charlotte Town Center, 1441 Tamiami Trail, Port Charlotte in Macy's parking lot
- \* Tringali Park Community Center, 3460 N Access Road, Englewood
- \* Parking lot of the former Muscle Car City Museum, 10175 Tamiami Trail, Punta Gorda

Charlotte County launched Info Hubs to help residents get information about available resources after the storms. An Info Hubs is available at South County Regional Park Recreation Center, 670 Cooper St., Punta Gorda, FL 33950.

Important public service announcement regarding construction on U.S. 41 from the Florida Department of Transportation - (FDOT), District One, is providing roadway improvements to U.S. 41 (Tamiami Trail) from William Street to the Peace River Bridge (441524-1). This project is entering Phase Two of construction as of September 12, the contractor will begin to pave portions of the proposed roundabout that will be constructed at the intersection of Tamiami Trail (U.S. 41) and Carmalita Street. During the process of Phase Two construction, motorists should follow the posted detour:

Phase Two construction detour - US 41 (Tamiami Trail) from William Street to Peace River Bridge: Construction Project: The contractor will pave portions of the proposed roundabout with base and structural asphalt. Signs are being placed for the phase two detour listed below. Motorists should expect daytime left lane closures northbound from William Street to Carmalita Street and southbound from Cross Street to William Street.

Phase 2 detour - Cross Street will be closed for the duration of phase two construction. Motorists attempting to access Carmalita Street from Cross Street will have to use the posted detour. They will turn left on West Charlotte Avenue, then right on Taylor Street, and continue until they reach Carmalita Street. Motorists are asked to exercise caution and reduce their speed while driving through the work zone. The construction schedule may change due to weather or other unexpected conditions.

Laishley Park Splash Pad - Construction continues at the Interactive Fountain area in Laishley Park. This work includes rehabilitation and upgrades to the splash pad/play area. Play equipment installation is nearly complete. Please use extra caution while driving or walking through the park due to construction personnel and equipment. To the highest extent possible the restroom facilities will remain open to the public. The access for the restrooms will be from the marina side of the building. There will be





periodic temporary sidewalk closures immediately adjacent to the construction area as required for public safety. The construction area will be closed to the public at all times during this period. The enhanced fountain area is scheduled to reopen in late 2024.

Fiber optic internet network - The fiber optic internet provider Hyper Fiber has been issued permits for a portion of the construction project to install a citywide fiber optic internet network within the City right-of-way. This project will be under construction during the next several months as they install the network citywide. They are currently working in the areas highlighted in red. The green areas are where the work is completed and their permit has been inspected for final by the engineering department. Additional areas are scheduled to be final in the next several weeks. The blue areas are where installation will take place as the project progresses. Construction is beginning in Burnt Store Isles and Burnt Store

Initially you will see utility markings within the City right-of-way, followed by the directional drilling of the fiber optic conduit. Fiber optic

boxes will be installed in the right-of-way or easement at the edge of your property. Once the installation of the underground and service points has been completed for the entire sector, crews will then return to individual locations for the restoration of sod. This will take place at the end of construction in each sector. Please be patient and allow time for the restoration. The City engineering department will be performing spot inspections during construction as well as a final inspection when the restoration is complete to ensure the contractor's restoration meets the City's requirements. dates to put on your calendar in advance of the upcoming primary and general elections. Make sure you update your Vote By Mail status, as you have to do it after every general election now by Florida statute. For information, click <u>HERE</u>.

Licensed/unlicensed contractors - As a reminder, all contractors who will be performing structural work on your home (roofs, pool cages, soffits, etc.) must be a contractor licensed in the State of Florida - click <a href="HERE">HERE</a> to check on a specific company, AND they must also be registered with the City of Punta Gorda in order to be able to pull a building permit, which is required by law. You can check on the status of a contractor's registration with the City by clicking <a href="HERE">HERE</a> and typing in the name of the company you wish to check on. Failure for a contractor to have the appropriate licensing and registration could result in a felony for the contractor. Additionally, they may not have the required insurance and liability insurances that the state requires. Please do your homework before you sign anything!

**Dockside dredging -** Property owners that are listed on the Hurricane Ian seawall damage list will not be allowed to have dockside dredging performed adjacent to the seawall until the seawall has been repaired. Any dredging along the damaged seawall may cause damage. **Stabilizing erosion** Just a friendly reminder for property owners to regularly check the condition of their tarps or plastic that is protecting the eroded areas. Tarps and plastic tend to become brittle in the sun and may start falling apart. Utilizing plastic during a rain event will help keep the soil in place preventing further erosion.

Canal maintenance seawall failure update - Construction schedules have been updated

and are posted on the Canal Maintenance website for the next six months look ahead. There are 20 projects in Punta Gorda Isles under construction with 113 projects completed, and all 30 seawall projects in Burnt Store Isles have been completed. Phase two has started in the SW Zone.

**Establishing sod after seawall replacement** - Placing the sod is the final phase of seawall replacement construction. As per the City ordinance, property owners are responsible for establishing the sod after it has been placed and the City will not reimburse the owners for their water usage.

**Vessel speeds** - Canal Maintenance is asking people to be mindful of the current situation in the canals with seawalls being damaged. City code states that the operation of vessels in the canals shall be Slow Speed Minimum Wake in the waterways within the City limits. The speed and operation in the Ponce Inlet, Pompano Inlet, Bass, and Snook Inlet are Idle Speed and No Wake. Wakes from watercraft can cause additional erosion and damage to seawalls already compromised.

Dock Match program - The Punta Gorda Boaters Alliance (PGBA) has once again set up a program called *Dock Match*, which is to help facilitate relocation of boats that will need to be temporarily relocated from properties that had seawall failures. If you have a dock that is vacant and would like to make it available to another PGI or BSI boat owner, please click HERE to register your dock. Boat owners will have a list available to assist them in connecting with you to try and match their needs to your dock availability. I worked with the PGBA after Hurricane Irma to set this up in 2017 and it was used quite a lot by many residents. This program has been approved by the PGBA and the City of Punta Gorda.

Answers to some of your questions - I receive many questions each week from residents, asking all kinds of things about Punta Gorda activities. Here are a couple from this week: EDITORIAL NOTE: I would like to thank all the residents that paid attention to the evacuation orders issued by Emergency Management, Charlotte County and the City of Punta Gorda. It definitely saved lives during this storm. A news reporter asked me this week what was different this time from other storms. My answer was "I have lived here for 28 years, and for Hurricane Charley, we were not ready." That was a major difference from then and now. And there was a major difference also between Helene and Milton. After Helene, first responders had to rescue 121 people and several dozen pets. After Milton and people paid attention, just three. So thank you everyone for helping to keep yourselves safe. We have learned a lot in recent years about hurricane preparedness, and it certainly makes a difference. I hope that most of you had minimal or no damage to your homes. I realize that there is still a lot of cleanup to be done, but we are a resilient community and will come back better and stronger.

I had a request to reprint the links to the information for the six Florida constitutional

amendments that will be on the ballot, so here is the information again since Vote by Mail ballots should be arriving soon:

I understand there are several ballot referendums on the general election ballot this year. Can you please explain what these are and what they all mean? This is always a complex answer, and without providing a personal opinion about each of them, I am offering a couple of documents every registered voter should read before voting this year. This one is a very clear description of each ballot and what a yes or no vote will mean - click HERE. And here is a second source for information - click HERE. I urge you to read through these thoroughly! A law passed in the Florida legislature a couple of years ago was intended for amendment verbiage to be spelled out in plain English, but my opinion is that there is still some text that may distort the intended meaning of the amendment. So please read carefully before you vote!

# **Fire Department:**

**Building Division** - Allowing an unlicensed person to perform work on your property puts you, as the owner, at risk. Unlicensed contractors are unable to obtain workers' compensation coverage, general liability insurance, or the proper permits for the work they are doing. Should injuries occur at the site, the owner may be liable. Any work performed without the proper permits may not be covered by the home or business owner's insurance company in the event of future claims.

Per *Florida Statutes* § 489.127(2)(c) (2022); "Any unlicensed person who commits a violation of subsection (1) during the existence of a State of Emergency declared by executive order of the Governor commits a felony of the third degree". The city remains in a state of emergency as a result of Hurricane Helene. Therefore, any person who does work without the correct licensure during a state of emergency may be charged with a felony. This applies to all types of construction and not just that which is associated with repairs as a result of a tropical storm or hurricane.

Peace River Wildlife Center - Construction has begun for the Peace River Wildlife Center located next to the Hounds on Henry Dog Park! This work includes the development of the wildlife center and the expansion and reconstruction of the parking lot for the Hounds on Henry Dog Park. A temporary entrance to the dog



park has been constructed and will be opened soon. The existing entrance will only serve as a construction access to the Peace River Wildlife Center development area once the temporary entrance is opened. Please use the new temporary entrance once it has been opened to traffic for access to the Hounds on Henry Dog Park.

Please use extra caution while driving or walking through this area due to construction personnel and equipment. Please obey the newly installed stop signs as dump trucks are delivering fill dirt at the rate of approximately (30) loads per day. These trucks require a wide turn area, and vehicles should give them plenty of room to maneuver. The fenced

**Groundwater RO plant update -** Maximum total dissolved solids (TDS) is 500 without a waiver. Our numbers are consistently way below the maximum allowable level with the R.O. Plant water in service.

**Voters update signature** - Did you know your signature can change over the years? Ensure the Charlotte County Supervisor of Elections has an up-to-date record of your signature on file for the upcoming election. **Vote By Mail** - In order to vote by mail, you must have a valid request on file with the Supervisor of Elections Office. Vote By Mail requests must be renewed before every general election and if your VBM request was made prior to 12/31/2022, it has expired and must be renewed this year. Requests for vote-by-mail ballots can be made in person, by calling 941-833-5400 or by visiting the Supervisor of Elections website - click HERE.
